FIFE SHOW SHEEP ENTRIES INFORMATION

****Please read before completing entry form/online entry****

GENERAL INFORMATION

ENTRY FORMS must be completed by a person 16yrs old or over and the person completing the form should be, or become, a Member of the Association.

ONLINE ENTRY FACILITY: please ensure you have included Competing MEMBERSHIP and the £3 COMPULSORY PARAMEDIC FEE **per ring handler** before confirming your basket total. You will receive an email detailing your online entries processed – if this is not received soon after making your entries, please check your junk folder then contact the Show Organiser if still not there. This also acts as your VAT receipt, if required. **Details on how to use the entry system are enclosed on a separate document.**

FULL PAYMENT for entry **MUST** be made at the same time as the form is submitted, whether submitted by email or post. Please take note of the closing date(s) and ensure that entry forms and fees are lodged with the Secretary by that date. The fee you are due to pay will be dependent on the date your entry form **and** **fee** reaches the Secretary. Payment may be made by cheque or by Bacs. Telephone entries will **NOT** be taken as entry forms must be signed by exhibitor.

POSTAL ENTRIES: please DO NOT send cash in the post.

PARAMEDIC FEE: a compulsory fee of £3 **per ring handler** is payable to offset the cost of paramedic provision. Entrants in Classes with **no entry fee** (Young Handlers) do not need to pay a Paramedic fee for that Class.

TICKET ALLOCATION: Membership = 1 admission wristband; 1st animal entered = 1 admission W/B; 4th animal entered = 1 admission W/B (max 3 W/Bs) In 2024, admission wristbands will be posted to you in advance of the Show along with membership badges and vouchers for prepaid Catalogues, if applicable.

PLEASE NOTE: **children aged Under 16yrs** are admitted free of charge, when with an adult, and no wristband is required for them. If you require extra admission wristbands for those aged 16yrs or over, these can be purchased along with your entries.

CLOSING DATES: are detailed on entry forms. Entries for inclusion in the Catalogue must be submitted by 16th April. Thereafter, **Late Entries** (non-Catalogued) will be taken from 17th April – 8th May. **PLEASE NOTE – NO ENTRIES WILL BE ACCEPTED ON SHOWDAY.**

SUBSTITUTION OF ENTRIES: if you have entered an animal that is subsequently unable to come forward, you may replace it with a substitute – only for the **same class as originally entered**. Details of substitutes **must** be advised to the Secretary by **noon on 16th May** at the latest.

RULES: Please make sure you have read and are familiar with the **Fife Show Livestock Rules** at the front of the Premium List, on the Entries page of the website and on the online entry system. By **signing an Entry Form or making an online entry**, you are declaring that you have read, and agree to abide by, both the **Entries Information**, included herewith, as well as the Fife Show **Livestock Rules**.

MOVEMENT OF LIVESTOCK: Sheep must be on the Show Ground before 8.00am and not be removed until after the Parade of Livestock has finished.

MV Accredited sheep herd exhibitors must give a fully completed SRUC valid Certificate of Status to the Steward on entry to the showfield BEFORE unloading any animals. These will be validated and returned to SRUC.

This Show **WILL NOT** offer facilities suitable for Scrapie monitored flocks/herds.
