## FIFE SHOW HEAVY HORSE ENTRIES INFORMATION

**\*\*Please read before completing entry form/online entry\*\***

### **GENERAL INFORMATION**

- **\*\* PLEASE NOTE \*\*** Earrings/body studs, visible jewellery must not be worn in Light Horse or Heavy Horse classes – In-Hand, Ridden or Driven. If a Judge sees an exhibitor with earrings/body studs or visible jewellery, they should ask the exhibitor to remove them or leave the Ring. If the exhibitor does not remove them, the Judge will disqualify the exhibitor from the Class. The only time earrings may be kept in is if they cannot be removed for medical reasons, and exhibitors should advise the Show Organiser of this in advance. Earrings/body studs may not be taped or have plasters over them, they must be removed.

**ENTRY FORMS/ONLINE ENTRIES** must be completed by a person 16yrs old or over and the person completing the form must be, or become, a Member of the Association unless entering a HOYS Class **ONLY**. There are different entry forms for the Driven Heavy Horse section and the HOYS Ridden Heavy Horse Class. If entering online, all the required information will be asked when you enter. **Please note:** class timings and ring locations shown are in draft format and might be subject to change, once entries close.

**WRISTBAND ALLOCATION:** Membership = 1 admission wristband; 1<sup>st</sup> animal entered = 1 admission W/B; 4<sup>th</sup> animal entered = 1 admission W/B (max 3 W/Bs). Competitors entering HOYS classes **ONLY** do not need to become a member of the Association but will then not receive the membership wristband allocation. In 2026, admission wristbands will be **posted** to you in advance of the Show. **PLEASE NOTE: children aged Under 16yrs** are admitted free of charge when with an adult, they do not require an admission wristband. Extra wristbands for those aged 16yrs or over should be purchased with your entries if required.

**FULL PAYMENT** for entry **MUST** be made at the same time as the form is submitted, whether submitted by email or post. Please take note of the closing date(s) and ensure that entry forms and fees are lodged with the Secretary by that date. The fee you are due to pay will be dependent on the date your entry form **and** fee reaches the Secretary. Payment may be made by cheque or by Bacs. Telephone entries will **NOT** be taken as entry forms must be signed by exhibitor.

**POSTAL ENTRIES:** please DO NOT send cash in the post.

**ONLINE ENTRY FACILITY:** please ensure you have included Competing MEMBERSHIP and the £3 COMPULSORY PARAMEDIC FEE **per ring handler/rider/driver** before confirming your basket total. You will receive an email detailing your online entries processed – if this is not received soon after making your entries, please check your junk folder then contact the Show Organiser if still not there. This also acts as your VAT receipt, if needed. **Details on how to use the entry system are enclosed on a separate document.**

**PARAMEDIC FEE:** a compulsory fee of £3 inc. VAT per ring handler/rider/driver is payable to offset the cost of paramedic provision. Entrants in Classes with **no entry fee** (e.g. Young Handlers) do not need to pay a Paramedic fee for that Class.

**RULES:** Please make sure you have read and are familiar with the **Fife Show Livestock Rules** at the front of the Premium List, on the Entries page of the website and on the online entry system. By **signing an Entry Form or completing an online entry**, you are declaring that you have read, and agree to abide by, both the **Entries Information**, included herewith, as well as the Fife Show **Livestock Rules**.

**CLOSING DATES:** are detailed on entry forms. Entries for inclusion in the Catalogue must be submitted by Thursday 23rd April. Thereafter, **Late Entries** (non-Catalogued) will be taken from 24th April – 13th May. **PLEASE NOTE – NO ENTRIES WILL BE ACCEPTED ON SHOWDAY.**

**BROOD MARES:** must be four yrs. old or over. **Foals** must be at least 3 weeks old on Show day.

**HORSE AFFILIATIONS/QUALIFIERS:** Scone Palace Ridden Clydesdale Championship; British Ridden Heavy Horse Society (Equifest); Clydesdale Horse Society; Highland Pony Society; HOYS (Horse of the Year Show); NPS Scotland; and the Shetland Pony Stud-Book Society. See Notes at the start of the Heavy Horse Section in the Schedule for further details of relevant information

**\*\*PLEASE MAKE SURE THAT, IF ENTERING QUALIFIERS, YOU ARE AWARE OF, AND COMPLY WITH, EACH SOCIETY'S RULES & REQUIREMENTS\*\***

**SUBSTITUTION OF ENTRIES:** if you have entered an animal that is subsequently unable to come forward, you may replace it with a substitute – only for the **same class as originally entered**. Details of substitutes **must** be advised to the Secretary by **noon on 21st May** at the latest.

**INSURANCE:** as an exhibitor/owner, you are personally responsible for damages to third parties caused by you, your employees, support personnel, your agents or your animals. All exhibitors/owners, therefore, **must have valid third party liability insurance**.

**MOVEMENT OF LIVESTOCK:** Horses must be on the Show Ground before 8.00am and not be removed until after the Parade of Livestock has finished.

**PLEASE NOTE : Prize money** for Heavy Horse classes (Shetlands, Highlands, Clydesdales & Driven Heavy Horses) will not be given out until the conclusion of the Parade or 3p.m, whichever is later.

**HORSE PASSPORTS:** must be brought to the Show, as checks might be undertaken. **Please make sure that horses are entered for the Show in the same name as shown in their Passport.**

**HEAVY HORSE** competitors - please collect **Pre Paid Catalogues**, if purchased, from the Secretary's Tent at the Main Ring when you arrive at the Show. **Please ensure you also collect your numbers** from the Secretary before showing any animals as stewards have been instructed not to allow ring entry to any exhibitor without a number. It is important that numbers are worn to help us make sure results are accurate.
